### CONDITIONS OF USE for the Langlauf- und Biathlonzentrum OSTTIROL

#### General

When using the Langlauf- und Biathlonzentrum OSTTIROL, it is compulsory to register with the stadium management.

Users can register via email or by telephone.

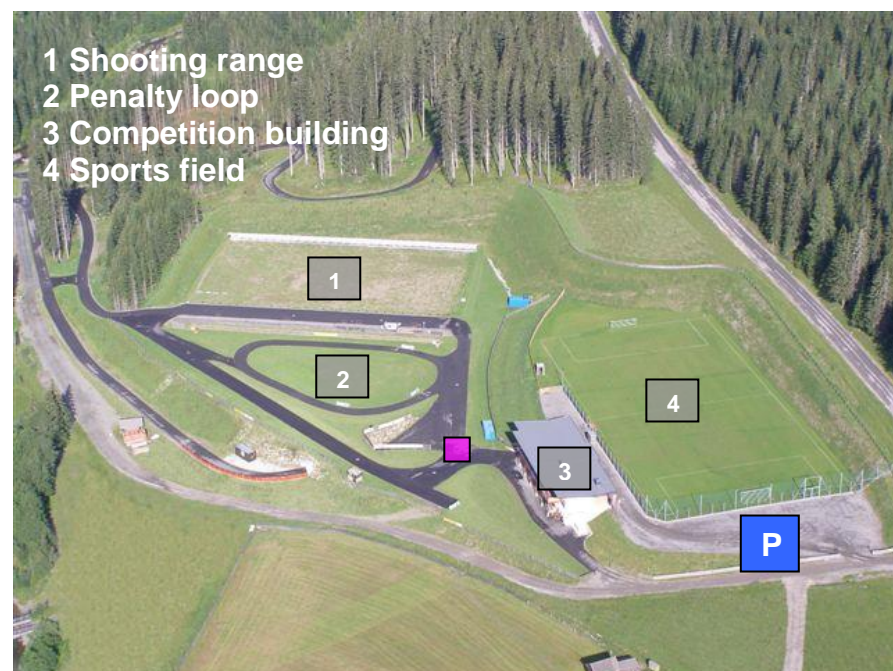
It is also necessary to register training sessions in plenty of time because maintenance work at the shooting range and in the stadium area has to be coordinated, etc.

### Conditions of use:

#### 1. General

- a.) Use of the Cross-Country and Biathlon Centre and any of its facilities is only permitted with the authorisation of the stadium management. Peter Hofer (stadium director) is primarily in charge of this, as the superintendence of the entire venue has been assigned to him. In principle, prior written registration is required in order for training groups to use the facility. However, it is sufficient for individual users to register by telephone as described above.
- b.) As a rule, the shooting range and roller-ski course is open from **9 a.m. - 6 p.m.** Exceptions may be made, however. Registration by name with the stadium management is required after the first training session at the very latest, with regard to payment of fees.
- c.) Vehicles must be parked in the parking lot on the north side of the competition building. Use of the access road south of the competition building is only permitted after consulting the stadium management, and the access is exclusively for the purpose of off- and on-loading.
- d.) The instructions of the stadium management must be followed without exception. Improper behaviour will lead to expulsion.
- e.) Users must abstain from littering. Rubbish is to be disposed of in the rubbish bins provided.
- f.) The Cross-Country and Biathlon Centre Ltd. assumes no liability for accidents or damages whatsoever. Use of the entire venue is at the user's own risk.

#### 2. Shooting range

- a.) Shooting is only allowed upon prior registration with the stadium management. National security regulations and those of the IBU must be adhered to. The stadium management will determine how the positions are to be divided up and allocated. The division and allocation of the shooting positions will be hung up on a display panel at the shooting range itself.
- b.) During any shooting, at least one experienced chief of shooting must assume supervision. He/she must ensure that those present at the shooting range do not cause any avoidable risks by their behaviour, and that spectators do not step onto the shooting range. The name of the chief of shooting is to be included in the registration.
- c.) Users may only shoot using air rifles and .22 small-calibre rifles at the facility. Rifles may only be deposited in the gun racks provided.
- d.) Every person using the shooting range must be familiar with how to operate a gun.

e.) Users may not step on to the shooting lanes during use.

f.) If the target equipment malfunctions, shooting must be stopped at all positions before a person may enter the danger zone. Before a supervisor enters the danger zone, the chief of shooting (supervisor) must order every gun at the shooting range to be unbolted. These are to remain unbolted until every single person has left the danger zone.

g.) No one may leave the shooting range with a loaded rifle.

#### 3. Roller-ski training course

- a.) It is not possible to use the roller-ski course before 8 a.m. due to cleaning!
- b.) Use of the roller-ski training course is at the user's own risk. No liability claims may be lodged against the operator. Downhill sections may only be used with the agreement of the respective coach and by those active athletes who have a sure command of roller-skiing. Before using the roller-ski course, coaches and support staff are obliged to view the roller-ski course together with the athletes in order to point out the dangerous parts, in particular in the downhill sections.
- c.) Using the roller-ski course is only permitted in the direction of skiing (arrows).
- d.) We recommend wearing appropriate safety gear for the user's own safety.
- e.) The course is off-limits when the road sweeper is being used on the roller-ski course. This will be indicated with a corresponding sign immediately before the competition building at the downhill section leading to the finish area underpass. (Sign says in German: "Skirollerbahn gesperrt! Kehmaschine unterwegs!", meaning: "Roller-ski course closed! Road sweeper being used! ■...Position of sign)
- f.) The roller-ski course passes through an area of forestry and farm pastures. So in exceptional cases, grazing cattle and/or other vehicles may be on and in the immediate vicinity of the roller-ski course despite appropriate barriers. This fact must especially be taken into consideration.
- g.) Use of the roller-ski training course by pedestrians, cyclists or other vehicles is forbidden.

#### 4. Usage fees

The usage fees are to be paid to the stadium management.
